

GUIDELINES FOR ABSTRACT SUBMISSION

- ♦ Abstract must be original research work and not have been presented earlier.
- ♦ Please use MS-Word formats only. Title must be in UPPERCASE, should be short and concise. (Times New Roman with font size 14 in Bold)
- ♦ The name of authors should follow immediately under the title in one line and underline the presenting author's name. (Times New Roman with font size 12 in Bold)
- ♦ The abstract should not be more than 300 words. (Times New Roman with font size 12)
- ♦ Clearly mention code of specialization in your abstract.

GUIDELINES FOR ORAL PRESENTATION (PowerPoint)

- ♦ Slide content should be in bulleted or point by point format and not in paragraph.
- ♦ Time for presentation should be strictly adhered to 8 minutes followed by 2 minutes for discussion.
- ♦ Participants should bring their presentation in a pendrive compatible with MS – PowerPoint format.

GUIDELINES FOR POSTER PRESENTATION

- ♦ The poster must be of 48 × 36 inches in portrait with white background.
- ♦ The poster should contain the title of the corresponding paper, the authors, institution, address and email ID.
- ♦ Briefly outline your aim and methods. The conclusions should be succinctly stated.

ABOUT THE INSTITUTE

Andhra University was constituted in the year 1926 by the Madras Act of 1926 and Sir C.R. Reddy as its founder Vice-Chancellor. Andhra University is one amongst the pioneer state Universities in AP. It has been accredited by NAAC with a score of 3.6/4.0 for a period of 7 years. Andhra University also secured 29th position in the overall ranking of the top 100 institutions given by NIRF 2019.

Andhra University is the second institute in the country to start Pharmacy courses at University level in late 1930's. The Pharmacy course was initially offered in the B.Sc. The importance of Pharmaceutical Sciences led to the formation of a separate department in 1951 as B. Pharm. course with late Prof. S. Rangaswamy as founder Head of the Department. M.Pharm. courses were started in 1954. A separate Faculty of Pharmaceutical Sciences was formed in 1975. In 2006, the department was elevated as one of the constituent Colleges of Andhra University, and was named as A.U. College of Pharmaceutical Sciences. At present, the college offers B.Pharm, Pharma.D, Pharma.D (PB), M.Pharm with eight specializations namely Pharmaceutical Technology, Pharmaceutical Biotechnology, Pharmaceutical Chemistry, Pharmaceutical Analysis, Pharmacology, Pharmacognosy, Regulatory Affairs and Pharmacy Practice and Ph.D. programme in all specializations.
