TERMS AND CONDITIONS

- 1. The firm should enclose their details of GST Registration, Drug License, PAN No. and Bank Account No. and Companies/Firms/Agencies must have established at least 5 years back
- 2. The sealed tenders should reach the office before the due date and time either in person or by post. The sealed tenders received after the stipulated time will not be accepted. The University is not responsible for postal delay, if any, in receipt of the sealed tenders within the stipulated period.
- Incomplete sealed tenders in any form will be summarily rejected. No correspondence shall be entertained in this regard
- 4. The firm shall furnish Demand Draft drawn in favour of the Registrar, Andhra University, Visakhapatnam, towards Security Deposit and EMD for an amount of Rs. 20,000/- at the time of submission of bid
 - (a) After completion of the evaluation process & concluding the bid, the EMD of the unsuccessful bidders will be refunded.
 - (b) Security Deposit and EMD shall be forfeited if a bidder withdraws his bid during the period of bid validity and also in the case of failure of supply of medicines in-time.
 - (c) Interest or any other charges will not be payable on the above EMD.

- 5. The sealed tenders will be opened at <u>05 PM on</u> <u>19th July 2025</u> in the chambers of the Registrar, Andhra University, Visakhapatnam
- 6. The acceptance of sealed tender (s) will be communicated to the successful bidder(s) only.
- 7. The items should be supplied as per requirement as and when demanded for a period of one year from the date of agreement. General Medicines have to be supplied within in a week from the date of purchase order. Special Medicines have to be supplied immediately as and when required
- 8. Payment shall be made within three months after receipt of medicines as per requirement, and supply of the same as per terms & conditions
- 9. The University reserves its right to accept the sealed tenders in total or part; or reject any sealed tender on administrative grounds. It it feels that any of the item, even it is not lowest rate when it is a quality product, the University can have a right to go for issuing purchase order for those items.
- 10. In case the items are not supplied within the stipulated time, the order will be cancelled without any intimation duly forfeiting the Security Deposit.
