Mode of study:

Three Years (Six Semesters) mandatory education at Andhra University, India One year (Two Semesters) mandatory education (includes UG project) at Blekinge Institute of Technology, Sweden.

ADMISSION INFORMATION

I. GENERAL

- This programme is designed for the advantage of Student community through which students can acquire both B.Tech. from AU and B.S.in Engineering degree from Blekinge Institute of Technology, Sweden in four years. The objective of the programme is to make undergraduate students enhance the international understanding and global skills to compete in the global labor market.
- Applications for admission into the programme will be processed by Andhra University, India in association with Blekinge Institute of Technology, Sweden.
- There will be no provision for students to discontinue the studies in the middle of the programme and claim alternative degree.
- All Admissions are purely provisional, and the University reserves the right to cancel the admission at any stage.
- The students will be provided an option to continue the Master's (PG) programmes offered at Andhra University or Blekinge Institute of Technology, Sweden or Master's (PG) programme if offered under collaboration through Andhra University. The structure of tuition fee which is adopted during the year of admission for Master's programme will be applicable to students unless otherwise agreed between BTH and AU.

2. ELIGIBILITY REQUIREMENTS

Candidates satisfying the following requirements shall be eligible for admission into the programme.

Candidates qualified with Intermediate Education (10+2 pattern) conducted by the A.P. Board of Intermediate Education (BIE)/CBSE/ICSE with Mathematics, Physics, Chemistry subjects. The students should have a minimum 70% marks during Intermediate education.

3. FEE STRUCTURE & SCHOLARSHIPS:

Note: The student under the cooperation will receive a strategic scholarship under agreement between AU and BTH. which reduces the tuition fee by 30% during the bachelor studies at BTH. i.e. 35 000 SEK (which is after reduction of 30% on tuition fee at BTH)

BTH Merit Scholarships:

The students are eligible to apply for BTH Scholarship (Tuition fee waivers) programme for further reduction on existing tuition fee for the fee movers for the BTH i.e. The selection for BTH scholarship will be done as per the merit of academic excellence among all the international students. BTH Scholarships are subject to availability. The level of scholarship (reduction) will decided by BTH Scholarship committee.

4. VISA REQUIREMENTS & ACCOMMODATION:

Students should be able to fund their travel & living expenses for the stay at Sweden. Students should be able to show a minimum financial requirement of SEK 8514 (Sweden Kronas) per month for the entire planned study period at Sweden. Documentation certifying one's own must be provided at the time of applying residence permit (VISA). For 12 Months stay in Sweden, the students should show minimum financial requirement of SEK 85140,

Approx. INR 6.8 Lakhs (As per the present currency exchange rate*) before Swedish Migration Board while applying for VISA (Student Residence Permit). The students should adhere to the rules mentioned in migrations board during the year of transition to BTH. For further details please visit www.migrationsverket.se

Accommodation at AU: Hostel accommodation will be provided at AU on first-cum-first basis.

Accommodation at BTH: The average accommodation cost will be around 50000 SEK / Annum during the study period at BTH, Sweden on sharing basis. BTH don't own the student accommodation. The students are provided with necessary information / guidance about the booking procedure to reserve the student accommodations offered by legitimate housing companies in Karlskrona. Cost of living: Living costs in Sweden depend largely on your individual lifestyle. A sample monthly budget is as follows:

- Food SEK 2000
- Accommodation SEK 4200
- Course literature SEK 400–1,000
- Other: clothing, hygenie, Bus card, telephone, leisure, etc. SEK 1,500

NOTE:-Students are responsible to show the required financial proofs to the migration authorities while applying for student permit (VISA). Either BTH or AU will not be responsible for the visa rejections caused on the grounds of insufficient financial funds/statements in front of Migration Board.

5. PLACEMENTS:

Candidates who have successfully completed the program are eligible for campus placements at AU as per AU norms.

6. AFTER BACHELOR STUDIES:

Master studies:

Transition to masters studies:

The students from AU are provided with a provision to continue the master's programs, i.e. two- year master programmes at BTH after the completion of their bachelor education in relevant specialization at BTH. In such case, the tuition fee level of free mover international students (adopted during the year of admission) will apply to the master's studies.

Credits requirement:

They can enter the master's studies by completing a minimum of 180 credits of BTH (which should include a minimum of 45 credits (i.e. approx. credits of one semester) from their studies at BTH) and should have passed all the prerequisite courses for the entry to master studies. The student can continue the master studies at BTH. However the degree will be awarded only after completion of all the courses at bachelor and masters studies.

Tuition Fee:

The current tuition fee (for the academic year 2020 at BTH) for free mover international students is 50000 SEK / semester. The current fee can reduce/increase by 10% to meet the actual cost of the tuition. The students can also apply for BTH Scholarship (tuition waiver) while making an application to the master studies. The students are selected based on merit among all the prospective international students who apply to BTH for master's studies.

Residence permit after bachelors:

The successfully completed students are eligible to extend their residence permit for one months in-order to seek employment or explore the possibilities of starting by their own business as per the regulations of migration board. For more details visit: www.migrationsverket.se

8. Capacity Building programme (optional):

Capacity Building Programme for Global Employability and Entrepreneurship (CBPEE, 15 credits), The CBPEE isdesigned with direct inputs / in close cooperation with Swedish Industry and it will be offered in addition to the agreed educational plan. The programme will result in up skilling the students with necessary practical and employable skills to meet the expectations from the industry and the knowledge for starting a startup companies. The programme is recommended for the students who want to exit with bachelor's degree at BTH. The fee for these credits will be equivalent to the fees charged for international free mover student4. The exact fee for the training will be communicated during the year of admission into the BTH. The estimated fee for the training varies between 17500 – 25000 SEK. This training provided subject to the need of the students.

9. HOW TO APPLY:

Candidates are required to download application form and Information booklet from the website.www.andhrauniversity.edu.in. The duly filled-in application form with two sets of enclosures and application processing fee of Rs.2,000/- in the form of DD drawn, in any nationalized bank in favor of "Dean, International Affairs, Andhra University" payable at Visakhapatnam should reach the office of the Dean, International Affairs, 1st Floor, Science and Technology Bhavan (AU Science College Principal's Office Building), Andhra University, Visakhapatnam-530003, Andhra University, India or in person before 5.00 pm on 18th Nov 2020.

Office of the Dean, International Affairs is not responsible for non-receipt or late receipt of applications sent by Post Courier. Incomplete applications are liable to be summarily rejected. 10. SELECTION CRITERIA:

The selection will be based on ranks obtained by the candidates in IIT JEE(MAINS) / AP EAMCET /TS EAMCET/AUEET/ Marks in BIE or Equivalent in the order of preference indicated.
